PETITION FOR REVIEW

Pursuant to Section 16(b) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), 7 U.S.C. § 136n(b), and Rule 15(a) of the Federal Rules of Appellate Procedure, Petitioners Rural Coalition,

Organización en California de Líderes Campesinas, Farmworker Association of Florida, Beyond Pesticides, and Center for Food Safety (collectively Petitioners) petition this Court to review the order of the United States Environmental Protection Agency (EPA) approving the interim registration review decision for the herbicide glyphosate (the Interim Registration). See Exhibit A.

Petitioners respectfully petition this Court to hold that: (1) EPA violated its duties under FIFRA in approving the Interim Registration; and (2) EPA violated the Agency's duties under the Endangered Species Act (ESA), 16 U.S.C. §§ 1533-44, by failing to consult with the United States Fish and Wildlife Service or the National Marine Fisheries Service to insure that the Interim Registration will not jeopardize any listed species or destroy or adversely modify any of their critical habitats, see 16 U.S.C. § 1536(a)(2); and (3) to grant relief as may be appropriate.

The challenged order was announced in a document signed on January 22, 2020, EPA Docket No. EPA-HQ-OPP-2009-0361. See Exhibit A.
